REMINDERS:

You must buy a full block of ice time. For example, there is open ice available on Mondays at 3:30 from September 6th through November 1ST - if you want the discounted rate, you must register for all 9 weeks. If you only want to skate on only four Mondays in September, you must pay the walk-on rate.

Switch Policy - During the Fall Schedule, each pre-registered skater is entitled to 7 switches (For 7 sessions, not days) to use during the Fall Session. This is a policy to help preregistered skaters who are unable to use the ice due to vacation, school functions, business trips, etc...
